

Notice of Primary Election

Notice is hereby given that on Tuesday the 13th day of May, 2014 at the polling places in the election precincts of Buffalo County, Nebraska, an election will be held. The polls will open at 8 a.m. CST and close at 8 p.m. CST. Said election will be for nominating candidates to various offices. In compliance with section 32-811, some races will not appear on the Primary Election as the number of candidates filing for office did not exceed twice the number of vacancies and some county candidates (due to the signing of LB 56 by the Governor on February 18th, 2014) are declared nominated and shall appear as Nominated Without Opposition and placed on the November 4th, 2014 General Election ballot. As provided in section 32-814, elections for Village Board Trustees, for Board of Education for Class II schools, and for Board of Directors for Educational Service Units will be held in the General Election.
